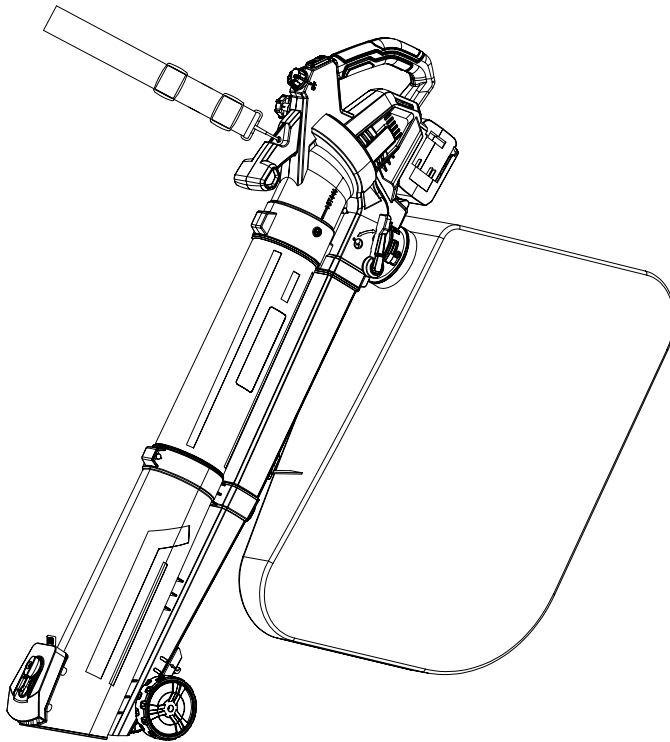

INTENDED USE

This device is suited solely for the vacuuming and blowing of light and dry materials such as leaves, garden waste, grass, small branches, and small pieces of paper.

The device is intended for private use on private land only.

This product is not intended for commercial use. Generally acknowledged accident prevention regulations and enclosed safety instructions must be observed.

Only perform work described in these instructions for use. Any other use is improper. The manufacturer will not assume responsibility for damage resulting from such use.

GENERAL SAFETY WARNINGS

- To operate this device safely, the user must have read and understood these instructions for use before using the device for the first time.
- Observe all safety instructions! Failure to do so may cause harm to you and others.
- Retain all instructions for use, and safety instructions for future reference.
- If you sell or pass the device on, you must also hand over these operating instructions.
- The device must only be used when it functions properly. If the device or part of the device is defective, have it repaired by a specialist.
- Never use the device in a room where there is a danger of explosion or in the vicinity of flammable liquids or gases.
- Always ensure that a device which has been switched off cannot be restarted unintentionally.
- Do not use devices with an on/off switch that does not function correctly.
- Keep children away from the device! Keep the device out of the way of children and other unauthorised persons.

You can reduce the risks considerably by following the tips below:

- Maintain the device in accordance with the instructions in the operating instructions.
- Avoid working at low temperatures.
- When it is cold, make sure your body and your hands in particular, are kept warm.
- Take regular breaks and move your hands at the same time to promote circulation.

Electrical safety

- The device may only be connected to a socket that is correctly installed and grounded.
- The fuse must be a residual current circuitbreaker with a measured residual current of no more than 30 mA.
- Make sure that the power supply corresponds with the connection specifications of the device before it is connected.

- If the device is not in use, make sure the plug is pulled out.

Handling rechargeable devices

Maintenance

- Before conducting any maintenance on the device, make sure the battery has been removed.
- Before conducting any maintenance on the device, disconnect the mains plug.
- Only those maintenance and fault elimination tasks described here may be carried out. Any other tasks must be completed by a specialist.
- Only use original replacement parts. Only these replacement parts are designed and suitable for the device. Other replacement parts will not only lead to an invalidation of the warranty, they may also endanger you and your environment.

SAVE THESE INSTRUCTIONS!

PRODUCT SAFETY WARNINGS

- When working with the device, always maintain a safe distance and natural body position.
- Always hold the device firmly in both hands.
- Before starting to work, check the working area for animals and objects. Remove all objects that may be slung away or become jammed in the cutting tool.
- Do not attempt to remove materials to be vacuumed or to hold material already vacuumed when the motor is running. Only remove any jammed material to be vacuumed when the device is switched off.
- No other persons or animals may be present within an area of 15 m around the vacuuming area, as they may otherwise be injured by objects being slung away.
- Only work in well lit conditions where visibility is good.
- Do not work above head height! Do not lean forward or back!
- The operator must wear tightly fitting clothing. Avoid wearing loose clothing. Wear sturdy shoes and long trousers.
- Take care when walking backwards. Danger of stumbling!
- Never work in the rain.
- Vacuuming or blowing of heavy materials such as metal, stones, branches, fir cones or broken glass is expressly forbidden.
- Keep all parts of your body away from the vacuum opening.
- When working with the device, ensure that there is sufficient lighting.
- Always wear the required personal protective equipment.

PRODUCT SAFETY WARNINGS

- Be careful of the dust you have raised and flying objects. Especially dangerous is the rebound effect on walls.
- Do not direct the device at people or animals when vacuuming or blowing.
- Before starting to blow, loosen foreign bodies with a rake or broom.
- The machine may only be operated during sensible hours – not too early in the morning or too late in the evening, as it may disturb other people.
- The times listed by the local authorities must be adhered to.
- The whole blower nozzle piece must be used so that the airstream can work close to the ground.
- Be aware of children and pets, close the windows and blow the foreign bodies safely away.
- Remember that moving parts may also be located behind ventilation and venting slots.
- Symbols which are on your device may not be removed or covered. Notes on the device which are no longer legible must be replaced immediately.



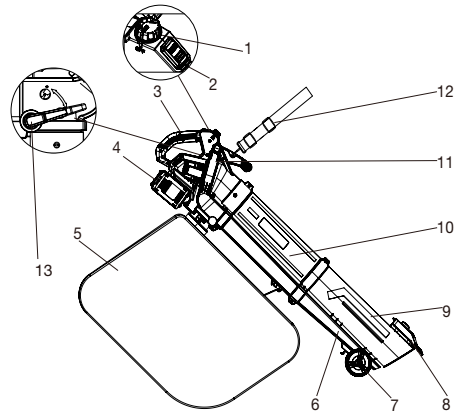

Parts description

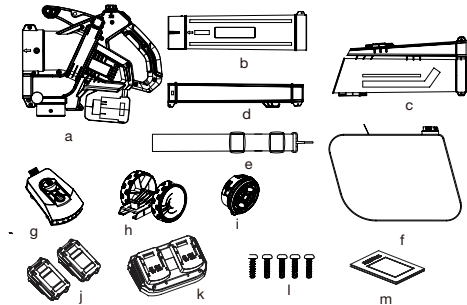
1. TURBO button

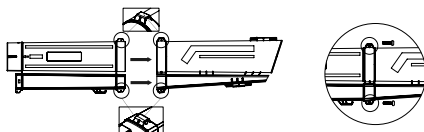

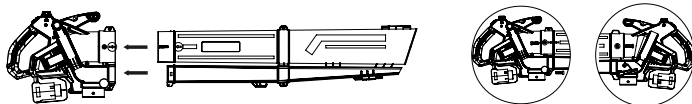
ASSEMBLY

Install the suction tube and shoulder strap

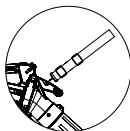
1. Insert the lower vacuum tube to the upper tube then fit the screws to lock the tubes together.



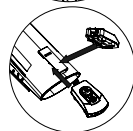
2. Insert the tube assembly to the main housing body and then fit the screws to lock into place.



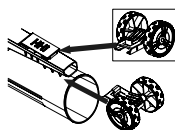
3. Hook the shoulder strap onto the device.



4. Insert the rake into the lower vacuum tube-you will hear a "click" as pictured.



5. Insert wheels into the lower blow tube-you will hear "click" as pictured.



OPERATION

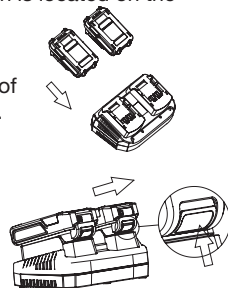
Charging the battery pack

NOTE: Remove the battery pack from the charger after it has been fully charged.

NOTE: Battery should be fully charged before first use.

NOTE: Make sure the mains voltage is the same as rating label which is located on the charger.

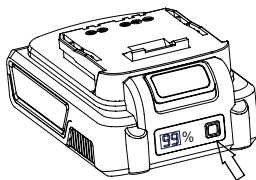
1. Connect the charger to a power supply. Red LED will light up.
2. To insert the battery pack into the charger, align the raised ribs of the battery pack with the grooves of the charger then push it in.
3. The red LED light of the charger will light up followed by green flashing light during the charging.
4. After charging is complete, the charger light will turn to a solid green light.
5. Once the battery is fully charged, depress the battery release button and then remove the battery pack.



OPERATION

Power indicator

This Li-Ion battery pack is equipped with a power indicator which is used to show the battery packs remaining charge. Press the power indicator button to check battery charge as picture shown. The indicator will stay lit for approximately 4 seconds.

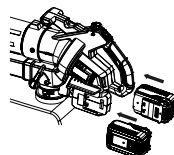


To obtain the best life from the battery

1. Never allow the battery to completely discharge before recharging. The battery pack should be placed on the charger whenever the battery pack is noticeably running down or the tool no longer performs a task it previously performed.
2. Avoid conducting short charges. Make sure that the battery is fully charged each time by allowing the charger to complete its full charging cycle.
3. Avoid allowing loose items like screws or nails etc. to be stored with battery packs as these or similar items can short battery packs and cause a fire or explosion.
4. Always unplug the charger when not in use and store in a dry and secure place.
5. Avoid charging or storing your battery in temperatures below 5°C and above 45°C.
6. After use, allow the battery pack to cool down for approximately 30 minutes before attempting to recharge.

To insert the battery pack

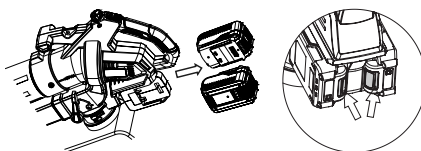
1. Align the groove on the battery pack with the corresponding ribs in the receptacle of the device.
2. Insert the battery pack with moderate force until it locks in to place.



WARNING: Only use Yard Force 20V original battery pack!

To remove the battery pack from the tool

1. Press the battery pack release button.
2. Remove the battery pack from the tool.



Check before starting!

DANGER! Risk of injury! The device must only be put into operation if no faults are found. If any part of the device is defective, it must be replaced before the next use.

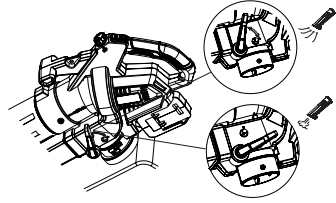

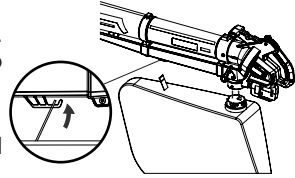
Selecting the operating mode

1. Set adjustment lever to vacuum or blower.
2. When using as a leaf vacuum: insert the collection bag as shown into the device and ensure that it clicks into place.
3. When using as a leaf blower: remove the collection bag and assemble the cap.



Attaching the collection bag

1. Hook the front of the collection bag to the device as shown.
2. Insert the nozzle of the collection bag as far as it will go into the device, then turn counter clockwise to lock.

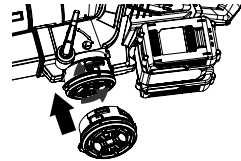


WARNING: Ensure that the bag has slotted into place securely.

Assemble the cap

When the machine will be used for blowing only addition of the cap.

1. Hook the cap into the nozzle.
2. Counter clockwise the cap and hear a "click".



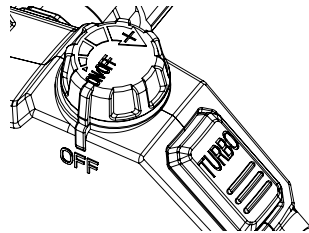
WARNING: Ensure that the cap has slotted into place securely.

Switching on and off

1. Turn the knob clockwise until hear a "click".
2. Continue to turn the knob to select the appropriate speed.



Note: Work with leaf blowers/vacuums may not be performed during normal quiet hours.



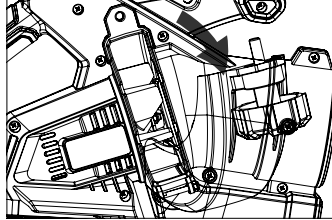
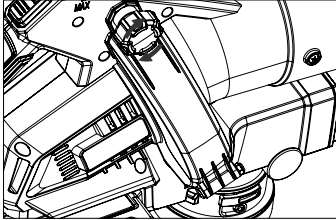
Switching TURBO

Press the TURBO button to get the highest speed.

OPERATION

Cleaning impeller blockage-Vision Windows

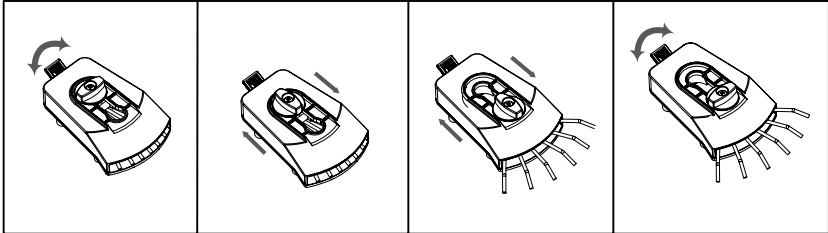
1. Turn OFF the device and remove the batteries.
2. Counter clockwise the knob to open the viewing window.



WARNING: Before use it must be removed the batteries.
WARNING: The Impeller blades can casue damage.

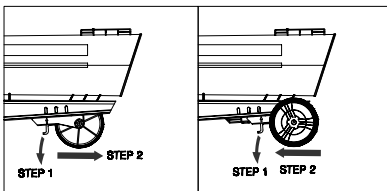
Rake Adjustment

- Turn the button on the rake and side it up and down.
- Turn the button again to put the rake in place.



Wheels Adjustment

- Step 1: Press the button on the wheels.
- Step 2: Move the wheels forward or bakwards.



MAINTENANCE AND STORAGE

DANGER! Risk of injury!

Switch off the product and disconnect the batteries before all cleaning and maintenance work. Wait until all moving parts are completely stopped.

Cleaning the device

- Brush off coarse dirt.
- Wipe down the device with a slightly damp cloth.
- Clean the collection bag regularly

Removing the collection bag

– Turn clockwise to release and remove the collection bag.

Storage, transport

Storage

DANGER! Risk of injury! Make sure that unauthorized persons do not have access to the device!

- Store the device in a dry place.
- Empty the collection bag before storing.

Transport

- Secure the device against slipping.
- If possible, use the original packaging for dispatching.

TROUBLESHOOTING

Fault/malfunction	Cause	Solution Action
Motor not running	Battery pack discharged?	Fully charge the battery pack
	Battery pack is not connected correctly	Install the battery pack once again
Blower/Vacuum not powerful enough	Collection bag full?	Empty Collection bag
	Suction speed too low?	Adjust the speed setting
Vacuum is not sucking up debris	Vacuum tube is blocked.	Clean vacuum tube and open vision door and clean impeller from debris.
